Po Leung Kuk Ngan Po Ling College A. School Fee Remission Scheme 2020/21

A. Aim

The School Fee Remission Scheme aims at providing financial assistance to eligible parents and enabling students to receive secondary education in Po Leung Kuk Ngan Po Ling College.

B. Eligibility Criteria

Applicant **MUST** be:

- (1) a parent or legal guardian of a student who has been enrolled to study F.1 to F.6 at Po Leung Kuk Ngan Po Ling College in the academic year 2020/21.
- (2) (a) For existing students, applicants MUST have applied for:
 - (i) School Textbook Assistance (TA) Scheme / Student Travel Subsidy (STS) Scheme / Subsidy Scheme for Internet Access Charges (SIA) provided by the Student Finance Office (SFO) and have received the 2020/21 Eligibility Certificates (ECs) from the SFO; or
 - (ii) Comprehensive Social Security Assistance (CSSA) Scheme by the Social Welfare Department and have received a valid Notification of Successful Application (NSA) of CSSA.
 - (b) <u>For newly admitted students</u>, applicants are advised to (but not a must to) apply for the ECs / NSAs before they apply for this remission scheme.

C. Method of Assessment

- 1. <u>For students who were admitted to the school in the academic year 2017/18 or before</u>, the school fee remission level will follow the Eligibility Level (either HALF or FULL) stated on the EC / NSA (treated as FULL).
- 2. For students who were admitted to the school in the academic year 2018/19 or after (including newly admitted students) with EC / NSA, the adjusted level of assistance will be determined by a two-tier means test involving the Eligibility Level (either HALF or FULL) stated on the EC / NSA (treated as FULL) and the accommodation status. The original level of assistance will be adjusted based on the accommodation status as shown in the following table:

- 3. **For newly admitted students without EC / NSA,** the school will follow the formula adopted by the SFO to calculate the Adjusted Family Income (AFI) as a means to assess the eligibility for assistance and the level of assistance.
 - (a) (i) The AFI mechanism is based on the following formula:

$$AFI = \frac{Gross Annual Income of the family in the preceding year}{Number of family members + (1)*}$$

- * For single-parent families of 2 to 3 members, the 'plus 1 factor' in the divisor of the AFI formula will be increased to 2.
- (ii) Gross annual income of the family includes the annual income of the applicant and his/her spouse; 30% of the annual income of unmarried child / children residing with the family if applicable; and the contribution from relatives / friends if applicable. (Refer to Appendix 1)
- (iii) The members of a family normally refer to the applicant, his/her spouse, unmarried child / children residing with the family and the dependent parent(s) who are supported by the applicant and/or his/her spouse.
- (iv) The AFI eligibility benchmarks for various levels of assistance in the 2020/21 school year are listed in the table below. Please note that the AFI is not the average monthly income of a family.

- * AFI thresholds for full level of assistance for 3-member and 4-member families are HK\$50,323 and HK\$46,297 respectively. For 2-member single-parent families and 3-member single-parent families, they are regarded as 3-member families and 4-member families respectively for determining the AFI thresholds for full level of assistance and calculation of AFI.
- (b) The original level of assistance will be adjusted based on the accommodation status as shown in the following table:

D. Application Procedure

- 1. Application for fee remission has to be made for every academic year.
- 2. Application forms can be obtained from the school office from 1 September 2020.
- 3. (a) For students who were admitted to the school in the academic year 2017/18 or before,
 (1) the Application Form, (2) the photocopy of the EC / NSA, should be duly completed and submitted to the school office in person by parents / guardian / student during office hours
 - (b) For students who were admitted to the school in the academic year 2018/19 or after (including newly admitted students) with EC / NSA, (1) the Application Form, (2) the photocopy of the EC / NSA, and (3) the photocopy of the Accommodation Status (Refer to Appendix 2) should be duly completed and submitted to the school office in person by parents / guardian / student during office hours.
 - (c) For newly admitted students without EC / NSA, (1) the application form, (2) all the required documents for calculating AFI (Refer to Appendix 3), and (3) the photocopy of the Accommodation Status (Refer to Appendix 3) should be duly completed and submitted to the school office in person by parents / guardian / student during office hours.
- 4. If proper documentary proofs cannot be provided or the documents provided cannot substantiate the reported income / accommodation status of the family concerned (e.g. claim for prolonged unemployment is not substantiated or only self-written statement of income is provided), adjustments will be made on the level of assistance.
- 5. The deadline of the application will be 30 September 2020.
- 6. The school will verify all applications after the deadline. Interview may be arranged if necessary.
- 7. Under normal circumstances, <u>the school will not accept any application for school fee</u> <u>remission submitted after the above deadline</u>. The school may give special consideration to cases with exceptional circumstances.
- 8. Families who have sudden financial difficulties during the year can apply for the contingency fund. They have to write a letter to the Principal to explain the financial situation with sufficient supporting documents.

E. Vetting Procedure

A Fee Remission Committee comprising the Principal and 2 or more responsible teaching staff appointed by the Principal will consider the applications for fee remission and contingency fund.

F. Release of Result

Notification of result will be sent to each applicant by the end of November 2020.

G. Procedure for Appeal

- 1. Applicant who is unsatisfied with the decision of the Fee Remission Committee concerning his/her application may apply for a review with sufficient grounds in writing and submit additional supporting documents within 10 days from the date of release of result.
- 2. An Appeal Committee comprising the Principal, Principal Assistant and 2 more responsible teaching staff appointed by the Principal will review the applications for appeal.
- 3. Decision of the Appeal Committee will be final.

4. The Appeal Committee will directly inform the applicant the result in writing.

H. Payment Arrangement

- 1. For over-paid school fee during September to November:

 The amount of fee remission will be reimbursed through autopay to successful applicant's bank account which school fee is debited from.
- 2. For unpaid school fee:

The school fee will be waived based on the amount of fee remission.

Students will be informed about the result in around November of the next academic year.

F. Procedure for Special Case

An ad hoc committee comprising the Principal and related teachers will consider any appeal or special case.

G. Payment Arrangement

The scholarship will be reimbursed through autopay / by a crossed cheque payable to the parents / guardians of the awardees in around December of the next academic year.

C. Scholarship Scheme for High Achievers in Internal Examination 2020/21

A. Aim

This scholarship scheme aims at:

- (1) recognizing and encouraging students' achievements in internal examinations; and
- (2) attracting and retaining students with high caliber.

B. For Junior Form and NSS HKDSE Students

1. Eligibility Criteria

Applicants MUST be:

- (1) F.1 F.5 students in Po Leung Kuk Ngan Po Ling College in the current year of examination;
- (2) continuing their study at Po Leung Kuk Ngan Po Ling College in the next academic year;

Students will be informed about the result in around January of the next academic year (for students mentioned under item B and C) or in around July of the current academic year (for students mentioned under item D).

G. Procedure for Special Case

An ad hoc committee comprising the Principal and related teachers will consider any appeal or special case.

H. Payment Arrangement

The scholarship will be reimbursed through autopay / by a crossed cheque payable to the parents / guardians of the awardee in around February of the next academic year. If students have their school places forfeited in or before November of the next academic year, the scholarship will not be reimbursed.

D. Fee Remission Scheme for Exchange Programme and Overseas Forum 2020/21

A. Aim

This fee remission scheme aims at providing equal learning opportunities for students with different social background.

B. Eligibility Criteria

Applicants MUST be studying at Po Leung Kuk Ngan Po Ling College in the academic year of joining the event.

C. Fee Remission

Students who are eligible for school fee remission assistance will be granted a fee remission of tour fee:

G. Payment Arrangement

The successful applicants only need to pay the remaining fee for the programme.

E. Fee Remission and Scholarship Scheme for International Competitions 2020/21

A. Aim

This fee remission and scholarship scheme aims at:

- (1) providing equal learning opportunities for students with different social background; and
- (2) encouraging participants to strive for the best results.

B. Eligibility Criteria

Applicants MUST be:

- (1) studying at Po Leung Kuk Ngan Po Ling College in the academic year of the competition; and/or
- (2) having outstanding achievements in international competitions.

C. World Scholar's Cup (WSC)

1. Eligibility Criteria

All groups that are qualified for the Global Round and Tournament of Champion (TOC) will be chaperoned by the school. No private candidates will be allowed.

The fee remission and scholarship will be reimbursed through autopay / by a crossed cheque payable to the parents / guardians of the awardees.

F. Scholarship Scheme for Outstanding Achievement in External Competitions 2020/21

A. Aim

This scholarship scheme aims at:

- (1) recognizing and encouraging students' achievements in extra-curricular activities; and
- (2) attracting and retaining students with high caliber in extra-curricular activities.

B. Eligibility Criteria

Applicants MUST be:

- (1) studying at Po Leung Kuk Ngan Po Ling College in the academic year of application; and
- (2) having outstanding achievements in extra-curricular activities.

C. Rubric

A rubric will be implemented to weigh the importance of awards in competitions. Competitions will be classified into three groups with different awards.

3. Scholarship

Scores will be accumulated throughout the academic year. A fixed amount of scholarship will be granted to students according to the ranking of total score:

If the total score of different students are tied at the margin, all students will be eligible for the scholarship.

D. Nomination Procedure

Data of students gaining awards in competitions will be entered by teacher-in-charge. Scores will be calculated at the end of the academic year. Students who are eligible will be automatically nominated. Students are not required to fill in any application form for the scholarship.

E. Vetting Procedure

A scholarship committee comprising the Principal, 2 members of extra-curricular activities committee and related teachers will consider the applications.

F. Release of Result

Students will be informed about the result in around October of the next academic year.

G. Procedure for Special Case

An ad hoc committee comprising the Principal and related teachers will consider any appeal or special case.

H. Payment Arrangement

The scholarship will be reimbursed through autopay / by a crossed cheque payable to the parents / guardians of the awardees in around November of the next academic year.

Po Leung Kuk Ngan Po Ling College G. Form 1 Admission Scholarship Scheme 2020/21

A. Aim

This scholarship scheme aims at enrolling new F.1 students with high caliber.

B. Eligibility Criteria

Applicants MUST be:

- (1) studying F.1 at Po Leung Kuk Ngan Po Ling College in the current academic year;
- (2) getting conduct B+ or above in P.5-P.6;
- (3) listed as the top in the admission score; and
- (4) selected and approved by the Principal and Form 1 Admission Committee.

C. Scholarship

Students who rank top 10 in the Form 1 Admission Scholarship Eligible List will be awarded a scholarship:

F. Procedure for Special Case

An ad hoc committee comprising the Principal and Form 1 Admission Committee teachers will consider any appeal or special case.

G. Payment Arrangement

The scholarship will be reimbursed through autopay / by a crossed cheque payable to the parents / guardians of the awardees in around February of the admission year. If students have their school places forfeited in or before November of the admission year, the scholarship will not be reimbursed.

Po Leung Kuk Ngan Po Ling College H. Moral Scholarship Scheme 2020/21

A. Aim

This scholarship scheme aims at:

- (1) recognizing and encouraging students' moral behaviours; and
- (2) enhancing students' awareness towards discipline and moral behaviours.

B. Eligibility Criteria

Applicants MUST be:

- (1) studying at Po Leung Kuk Ngan Po Ling College in the current academic year;
- (2) having no records for major demerit, demerit nor minor demerit; and
- (3) getting conduct B+ or above in the current academic year.

C. Scholarship

Top 3 students in each form will be awarded a scholarship of \$1,000.

D. Nomination Procedure

Every subject teacher of each class will vote for 1-3 students who show respect, politeness and helpfulness in each class. The student(s) with the highest average number of votes (average = number of votes / total number of subjects he/she studies) in each class will first be selected and the top 3 students will be further selected among them base on their average number of votes. Top 3 students will be automatically nominated. Students are not required to fill in any application form for the scholarship.

E. Release of Result

Students will be informed about the result before the Year-end Ceremony.

F. Procedure for Special Case

An ad hoc committee comprising the Principal and related teachers will consider any appeal or special case.

G. Payment Arrangement

The scholarship will be reimbursed through autopay / by a crossed cheque payable to the parents / guardians of the awardees in around September of the next academic year.

I. Po Leung Kuk Ngan Po Ling College Scholarship Scheme 2020/21

A. Aim

This scholarship scheme aims at recognizing F.6 students of the Po Leung Kuk Ngan Po Ling College who have achieved outstanding results in the HKDSE or the IBDP Examination.

B. Eligibility Criteria

Applicants MUST be:

- (1) studying F.6 in Po Leung Kuk Ngan Po Ling College in the current year of examination;
- (2) having at least two 5** in the HKDSE or at least three Higher Level 7 in the IBDP Examination;
- (3) having Level 5 or above in both HKDSE Chinese Language and English Language, or 7 in Language B and 6 or more in Language A in the IBDP Examination;
- (4) having impressive achievement in extra-curricular and academic-related activities; and
- (5) getting conduct B+ or above in the current year of examination.

C. Scholarship

Eligible students will each receive a \$10,000 scholarship. If there are more than five students who have achieved the same outstanding results, the scholarship (i.e. \$50,000) will be shared equally among the eligible students. Students who have already been awarded other scholarships can also be awarded this scholarship if they meet the above criteria.

D. Nomination Procedure

Students who are eligible will be automatically nominated. Students are not required to fill in any application form for the scholarship.

E. Vetting Procedure

An ad hoc committee comprising the Principal and related teachers will consider all the applications. The list of awardees must be approved by the current chairman of the Board of Directors of Po Leung Kuk, a vice-chairman and the chief executive officer.

F. Release of Result

Students will be informed about the result in around November of the next academic year.

G. Procedure for Special Case

An ad hoc committee comprising the Principal and related teachers will consider any appeal or special case.

H. Payment Arrangement

The scholarship will be reimbursed through autopay / by a crossed cheque payable to the parents / guardians of the awardees in around December of the next academic year.
